

## **Delegation of the President's Power Rules**

This is an additional set of rules to the rules and regulations of Cercle des Étèves de l'École des Mines d'Alès. It specifies, as the association's statutes enforce, the procedures for any delegation of the President's power.

The President of Cercle des Étèves is entrusted with certain powers detailed in Article 12 of the statutes. If the Board of Directors agrees, he may delegate part of his powers to a delegatee. In this context, the Board of Directors will ensure that this delegation does not exceed the powers held by the President, and that the powers delegated are only exercised within the restricted framework of the mission for which the delegation is made. It is necessary for the delegatee to have the time, skills, authority and means necessary to perform this mission.

The delegation of powers must be done in writing, signed by the President of Cercle des Étèves and given in two copies, one to the President and one to the delegatee. It will include :

- The start and end dates for the transfer of powers, which may be modified by the signing of a new delegation.
- An exhaustive list of the missions and powers that the delegator intends to entrust to the delegatee. A sample delegation of powers is available in the annex to these rules.

Any delegation of powers implies an exchange of responsibility to the delegatee in respect of all decisions taken for the mission laid out in the delegation. Moreover, it can be revoked at any time by the President of Cercle des Étèves and is maintained after the latter's possible termination of office.

## **Annex – Sample Delegation of Power**

In relation to the article 12 of Rules and Regulations of Cercle des Élèves,  
After deliberation by the Board of Directors on the DD/MM/YYYY,

I, the undersigned First Name NAME, in my capacity as President of the Cercle des Élèves of the École des Mines d'Alès,

Delegate, to First Name NAME, in his capacity as <function>,

The President's following power :

- <Delegated power>

The powers granted are strictly limited to <mission to be performed by the delegatee>. The delegatee renews their commitment to act in accordance with the decisions of the Board of Directors of Cercle des Élèves de l'École des Mines d'Alès. They must be able to present all supporting documents at the request of the President of Cercle des Élèves.

The Boards of Directors has ensured that this delegation of powers complies to the conditions set out in Delegation of the President's Power Rules, the additional rules n°2 of Rules and Regulations.

This delegation of powers shall be effective from DD/MM/YYYY and shall end on DD/MM/YYYY. On this expiration date, First Name NAME shall automatically be divested of their power, which shall revert to the President of the association.

As specified in the Rules and Regulations, any delegation of powers by the President entails an exchange of responsibilities to the delegatee, is revocable at any time by the President of the association, and is maintained after a possible termination of their role.
